Organization Description:

The Sport Product Testing (SPT) group at the Canadian Sport Institute Alberta (CSIAB) works with companies in the markets of sports, wellness, and health to help them make their products better and more usable to the end user. SPT works collaboratively with companies like Nike, Adidas, Under Armour, Polar, and Lululemon to help in the research of products such as athletic footwear, apparel, and wearable technologies.

Project Duties/Responsibilities:

Practicum students will:

- Partner with member(s) the SPT team at CSIAB and work on various ongoing projects related to improving product performance
- Learn to use technologies for data collection and analysis in the fields of biomechanics and physiology
- These technologies could include video capture systems, inertial measurement units, heart rate monitors, pressure sensors, and force platforms, used for the collection and assessment of data related to athlete and product performance
- Analyze performance and product related data which are collected using the above-mentioned technologies
- Be involved in day-to-day operations of SPT, including group meetings related to ongoing projects
