Project Duties/Responsibilities:

Under strict supervision, the practicum student will:

- Assist with spring camp (10-15 year old athletes) by leading warm up activities (a/b/c's, Frankensteins, can
 openers) and football specific drills such as throwing, catching, backpedaling, tackling fundamentals and bomb
 drills.
- Assist in set up and cleanup of camps (setting up cones, preparing weight station, cleaning garbage left out after camp).
- Helping run unique conditioning drills for players
- Helping run alternative drills for injured players
